Objectives and investment policy

The objective of the Sub-Fund is to maximise total rates of return, meaning capital appreciation plus income of its investments, over the medium term primarily from returns of Credit Derivatives, with prudent levels of risk while maintaining generally moderate levels of volatility. It intends to achieve the investment objective by generating income and capital appreciation through the Income Portfolio (i.e. the Sub-Fund's long exposure) while seeking to reduce the market risk of the Income Portfolio through the Hedge Portfolio (i.e. the Sub-Fund's short exposure). This will be achieved primarily through long or short exposure via Credit Derivatives.

- The investment process used by the Sub-Fund is generally systematic and research driven in nature. The Sub-Fund's investment process combines a systematic approach (i.e. a rules-based core strategy) with an active discretionary overlay.
- The Sub-Fund will invest in the following instruments through the Income and/or Hedge Portfolio: Credit derivatives on credit default swap indices and OTC Total Return Swaps on corporate debt indices.
- The following will be invested in as part of collateral assets: fixed or floating rate investment grade debt securities issued by members of the EU and developed market corporates and collective investment schemes investing in investment grade corporate debt securities.

- The Share Class of the Sub-Fund will accumulate income in its value.
- This Sub-Fund may not be appropriate for short-term investment.
- The Share Class is denominated in EUR. The Sub-Fund is denominated in EUR.
- Shareholders may subscribe/redeem units at the appropriate NAV per share provided an order request is received by the ICAV by the trade cut-off time 4.30pm (London time). Orders will be dealt the following working day. Subscriptions/redemptions must meet the minimum amounts as set out in the supplement of the Sub-Fund.

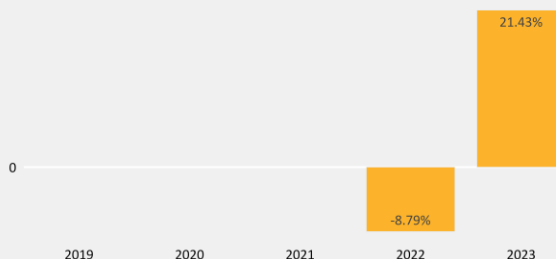
